Follow-Through Activity: Conduct of Local Road Performance Assessment through a Focus Group Discussion

Activity Design

I. Rationale

The Department of Interior and Local Government – Office of Project Development Services (DILG-OPDS) through the Program Management Office CMGP (PMO-CMGP) in its commitment to strengthen the capacities of the LGUs in the area of roads development and management has designed several capacity development activities intended for its 81 beneficiary provinces.

The program does not only provide physical infrastructure but also capacity development support for the improvement of local roads management and service delivery. The governance reform areas are focused on Local Road Management (LRM) and Public Financial Management (PFM).

2018 Local Road Management Performance Assessment (LRMPA). LRMPA is being conducted primarily to assess how effective and efficient the LGUs in fulfilling their mandate on LRM and to know how the LGU can be assisted to perform well in this area.

CY 2017 and 2016 LRMPA was conducted through a self-assessment process. This was due to time constraint and lack of personnel who would handle the assessment. As a result, the LRMPA was accomplished either by the PPDO or PEO not through a Focus Group Discussion (FGD) as originally designed.
